### Application Process

The application process is outlined below:

- 2) LSV will acknowledge the receipt of all applications following the closing date.
- 3) During the evaluation period, clubs may be requested to submit additional information and personally discuss the application in detail.
- 4) By completing this form, your club will be considered to host the appropriate carnival/s, and if successful, will receive further documentation as to the host club's responsibilities.
- 5) Following confirmation, both the successful and unsuccessful clubs will be notified in writing and the official dates and venues published.

## **Selection Process**

Both the Youth & Leadership Development (Y&LD) Executive and the Aquatic Sports Executive (ASE) are responsible for the selection of venues and will review all applications. Both Executives reserve the right to approach clubs to host carnival/s if they believe overall competition in Victoria will benefit.
