### **Application Process**

The application process is outlined below:

- 1) Complete the expression of interest form and return it to Andrew Skillern at LSV **no later than 5.00 pm Monday, 30 April 2007.**
- 2) LSV will acknowledge the receipt of all applications following the closing date.
- 3) During the evaluation period, clubs may be requested to submit additional information and personally discuss the application in detail.
- 4) By completing this form, your club will be considered to host the appropriate carnival/s and if successful will receive further documentation as to the host club's responsibilities.
- 5) Host clubs will be informed of the final decision in writing.
- 6) Following confirmation, both the successful and unsuccessful clubs will be notified in writing and the official dates and venues published.

### **Selection Process**

The Youth & Leadership Development (Y&LD) Executive is responsible for the selection of venues and will review all applications. The Y&LD Executive reserves the right to approach clubs to host carnival/s if it believes overall competition in Victoria will benefit.
