Subject: 2008-2009 Club Administration Grants

Action: Ensure grant criteria is complied with by stipulated dates

Clubs currently affiliated with Life Saving Victoria (LSV) will receive financial support as a result of undertaking a number of administrative tasks by due dates.

These administrative tasks have been selected as they ensure a club is performing at an appropriate level for an affiliated life saving club and assists the state to report out to various agencies and government departments. These reports are critical as they support our organisation's ongoing funding requests.

Once the series of administrative tasks have been completed before the due date, the related funds will be paid to the club by the specified date.

Clubs with issues in meeting these dates can appeal to the Life Saving Operations Executive in writing within one (1) month of the relevant grant group closing date. Clubs that fail to meet any requirements by the due dates will be notified in writing. This notification will be no later than the paid dates of the relevant grant group in question.

It is Life Saving Victoria's intention that all clubs meet these requirements and obtain the funds as it is perceived to be within the club's ability to do so. If any club foresees difficulty with achieving these requirements by the due date they should contact the Life Saving Operations Executive in writing as soon as possible to help resolve the difficulty.
